**PRELIMINARY RECITALS**

Pursuant to a petition filed February 01, 2013, under Wis. Admin. Code § HA 3.03(1), to review a decision by the Dane County Department of Human Services in regard to FoodShare benefits (FS), a hearing was held on February 27, 2013, at Madison, Wisconsin.

The issue for determination is whether the county agency correctly reduced the petitioner's FoodShare (FS) benefits effective February 1, 2013, due to an increase in earned income due to new employment.

**FINDINGS OF FACT**

1. Petitioner (CARES # [REDACTED]) is a resident of Dane County who resides with three children.
2. The petitioner's receives FoodShare (FS) benefits for a household of four.

3. As of about December 7, 2012, petitioner began new employment as a caretaker for Community Living Alliance earning about \$696 per month.
4. One of petitioner's children, DG, receives SSI of \$793.78 per month.
5. The petitioner's two other children each receive \$220 per month in Kinship Care benefits.
6. The county agency sent a January 3, 2013 Notice of Decision to the petitioner stating incorrectly that her FS benefits would be reduced from \$427 to \$108 effective February 1, 2012, due to an increase in her earned income from her new employment.
7. The county agency sent an updated and corrected February 1, 2013 Notice of Decision to the petitioner stating that her FS benefits would be increased from \$108 to \$178 as of effective February 1, 2012, due to petitioner providing to the county her January, 2013 paystubs from her new employment.

### DISCUSSION

In determining the amount of FS to be issued each month, the county must **budget all income of the FS household, including all earned and unearned income.** 7 C.F.R. §273.9(b). From the gross household income, certain deductions as discussed in the *FoodShare Wisconsin Handbook*, §4.6 are allowed: (1) standard deduction - which currently is \$134 per month for all households. 7 C.F.R. §273.9(d) (1); (2) earned income deduction - which equals 20% of the household's total earned income. 7 C.F.R. §273.9(d) (2); (3) medical expense deduction - for medical expenses exceeding \$35 in a month for an elderly or disabled person. 7 C.F.R. §273.9(d) (3); (4) dependent care deduction for child care expenses. 7 C.F.R. §273.9(d) (4); and (5) shelter expenses deduction - the deduction is equal to the excess expense above 50% of net income remaining after other deductions. 7 C.F.R. §273.9(d) (5). The maximum FS allotment amounts, based on household size, are listed at *FoodShare Wisconsin Handbook*, §8.1.7. The *FS Handbook* can be viewed online at <http://www.emhandbooks.wi.gov/fsh/>.

During the February 27, 2013 hearing, ESS Maggie Zimmerman, provided petitioner a detailed explanation regarding the re-calculation of the February 1, 2012 reduction in petitioner's FS benefits to \$178, and that the county is simply following FS law and policy. During that hearing, petitioner was unable to refute the county agency's case that it had correctly calculated the petitioner's income for a FS household of four based upon budgeting petitioner's new earned income from Community Living Alliance. In reviewing the county agency's calculation of petitioner's FS benefits based upon FS policy and law, I find no error. Accordingly, for the above reasons, I must conclude that the county agency correctly reduced the petitioner's FoodShare benefits from \$427 to \$178 effective February 1, 2012, due to an increase in petitioner's earned income from new employment.

### CONCLUSIONS OF LAW

The county agency correctly reduced the petitioner's FoodShare (FS) benefits effective February 1, 2013, due to an increase in earned income due to her new employment.

**THEREFORE, it is**

**ORDERED**

The petition for review herein be and the same is hereby Dismissed.

**REQUEST FOR A REHEARING**

This is a final administrative decision. If you think this decision is based on a serious mistake in the facts or the law, you may request a rehearing. You may also ask for a rehearing if you have found new evidence which would change the decision. Your request must explain what mistake the Administrative Law Judge made and why it is important or you must describe your new evidence and tell why you did not have it at your first hearing. If you do not explain these things, your request will have to be denied.

To ask for a rehearing, send a written request to the Division of Hearings and Appeals, P.O. Box 7875, Madison, WI 53707-7875. Send a copy of your request to the other people named in this decision as "PARTIES IN INTEREST." Your request for a rehearing must be received no later than 20 days after the date of the decision. Late requests cannot be granted.

The process for asking for a rehearing is in Wis. Stat. § 227.49. A copy of the statutes can be found at your local library or courthouse.

**APPEAL TO COURT**

You may also appeal this decision to Circuit Court in the county where you live. Appeals must be served and filed with the appropriate court no more than 30 days after the date of this hearing decision (or 30 days after a denial of rehearing, if you ask for one).

For purposes of appeal to circuit court, the Respondent in this matter is the Department of Health Services. After filing the appeal with the appropriate court, it must be served on the Secretary of that Department, either personally or by certified mail. The address of the Department is: 1 West Wilson Street, Madison, Wisconsin 53703. A copy should also be sent to the Division of Hearings and Appeals, 5005 University Avenue, Suite 201, Madison, WI 53705-5400.

The appeal must also be served on the other "PARTIES IN INTEREST" named in this decision. The process for appeals to the Circuit Court is in Wis. Stat. §§ 227.52 and 227.53.
