The Dane County Department of Human Services requested a hearing under 7 C.F.R. §273.16 requesting that a FoodShare Intentional Program Violation determination be entered against ■■■■ ■■■■ and that a one year disqualification penalty be imposed because the respondent failed to report her spouse's considerable earned income, thereby creating a large overpayment.

Prior to the administrative law judge holding a hearing, the respondent signed a waiver. Therefore, the agency may impose the requested sanction.

**NOW, THEREFORE,** it is **ORDERED**

That the respondent, ■■■■ ■■■■, is hereby ineligible to participate in the FoodShare program for a period of one year, effective November 1, 2013.

**APPEAL TO COURT**

You may appeal this decision to Circuit Court in the county where you live. Appeals must be served and filed

with the appropriate court no more than 30 days after the date of this hearing decision (or 30 days after a denial of rehearing, if you ask for one).


