PRELIMINARY RECITALS

Pursuant to a petition filed October 22, 2013, under Wis. Admin. Code § HA 3.03(1), to review a decision by the Barron County Department of Human Services in regard to FoodShare benefits (FS), a hearing was held on November 20, 2013, at Barron, Wisconsin.

The issue for determination is whether the county agency correctly determined the petitioner's FoodShare allotment.

FINDINGS OF FACT

1. The petitioner (CARES # [REDACTED]) is a resident of Barron County.
2. The petitioner seeks \$189 per month in FoodShare.
3. The county agency now agrees that the petitioner is entitled to \$189 per month in FoodShare.

DISCUSSION

FoodShare benefits depend upon household size and net income; net income depends upon what deductions are allowed from gross income. The petitioner receives income on rental property. Recipients are entitled to a 20% deduction for earned income. The agency initially did not allow the petitioner this deduction because it did not believe he was working 20 hours per week managing the property. It now concedes that he is. With this deduction, the petitioner's FoodShare allotment increases to \$189 per month, which is what he seeks. Because he is now receiving all of the benefits he seeks, the matter is moot and will be dismissed.

CONCLUSIONS OF LAW

The petitioner's appeal is moot because the agency has agreed that he is entitled to an earned income deduction and \$189 in FoodShare each month.

THEREFORE, it is

ORDERED

The petitioner's appeal is dismissed.

REQUEST FOR A REHEARING

This is a final administrative decision. If you think this decision is based on a serious mistake in the facts or the law, you may request a rehearing. You may also ask for a rehearing if you have found new evidence which would change the decision. Your request must explain what mistake the Administrative Law Judge made and why it is important or you must describe your new evidence and tell why you did not have it at your first hearing. If you do not explain these things, your request will have to be denied.

To ask for a rehearing, send a written request to the Division of Hearings and Appeals, P.O. Box 7875, Madison, WI 53707-7875. Send a copy of your request to the other people named in this decision as "PARTIES IN INTEREST." Your request for a rehearing must be received no later than 20 days after the date of the decision. Late requests cannot be granted.

The process for asking for a rehearing is in Wis. Stat. § 227.49. A copy of the statutes can be found at your local library or courthouse.

APPEAL TO COURT

You may also appeal this decision to Circuit Court in the county where you live. Appeals must be served and filed with the appropriate court no more than 30 days after the date of this hearing decision (or 30 days after a denial of rehearing, if you ask for one).

For purposes of appeal to circuit court, the Respondent in this matter is the Department of Health Services. After filing the appeal with the appropriate court, it must be served on the Secretary of that Department, either personally or by certified mail. The address of the Department is: 1 West Wilson Street, Room 651, Madison, Wisconsin 53703. A copy should also be sent to the Division of Hearings and Appeals, 5005 University Avenue, Suite 201, Madison, WI 53705-5400.

The appeal must also be served on the other "PARTIES IN INTEREST" named in this decision. The process for appeals to the Circuit Court is in Wis. Stat. §§ 227.52 and 227.53.
