PRELIMINARY RECITALS

Pursuant to a petition filed August 13, 2014, under Wis. Stat. § 49.45(5)(a), to review a decision by the Portage County Department of Human Services in regard to Medical Assistance, a hearing was held on September 02, 2014, at Stevens Point, Wisconsin.

The issue for determination is whether the Department erred in determining petitioner's eligibility for BadgerCare.

FINDINGS OF FACT

1. Petitioner (CARES # [REDACTED]) is a resident of Portage County.
2. Petitioner submitted his online renewal for the BC+ Core Plan program on July 7, 2014, which was pended by the respondent for verification of income.

3. The respondent received income verification and calculated net, or counted, income for petitioner in the amount of \$1,182.49. The counted income limit is \$972.50.
4. The verified income placed the petitioner at 238% of the federal poverty level. The Department sent notice to petitioner informing him denying eligibility for BadgerCare effective 9/1/2012.
5. Petitioner filed a timely request for hearing.

DISCUSSION

BadgerCare Plus is Wisconsin’s medical assistance program for those who are not elderly or disabled. Effective April 1, 2014, the governor and legislature lowered the amount of adjusted gross income a household can have and still be eligible for benefits to 100% of the federal poverty level for adults and 300% for children. Wis. Stat. § 49.471(4)(a). The county agency determined that the petitioner is ineligible for benefits because his household income exceeds 100% of the federal poverty level. For a one-person household, the size of the petitioner’s, 100% of the federal poverty level is \$972.50 per month. *BadgerCare Plus Handbook*, § 50.1. The respondent calculated that the petitioner earns \$1,182.49 per month. Because this is well over 100% of the federal poverty level, the agency correctly determined that the petitioner is ineligible for benefits.

In this case petitioner reported his income change as required, and the county changed FS for the following month based upon the report and verification. Petitioner argued that the county was aware the job was seasonal, and that while there have not yet been lay-offs, there have been many weeks where his hours were reduced. Petitioner offered testimony that his seasonal job has already begun winding down, though this assertion was not corroborated by any documentation.

While I can certainly empathize with the difficulty presented by working in a highly seasonal environment as the petitioner does, I can also empathize with the county agency’s obligation to follow BadgerCare policy in such circumstances. I note that the county cannot assume that the job will end at a certain time, and it is incumbent upon the petitioner to ensure that the respondent has the most accurate income information available. Based upon my review of the record in this matter, I do not find that the petitioner has established any error on the part of the respondent in determining petitioner’s BadgerCare eligibility as of September 1, 2014. The respondent made its determination based upon the best information available to it at that time.

CONCLUSIONS OF LAW

The petitioner is ineligible for BadgerCare Plus because his income exceeds 100% of the federal poverty limit.

THEREFORE, it is

ORDERED

The petitioner's appeal is dismissed.

REQUEST FOR A REHEARING

You may request a rehearing if you think this decision is based on a serious mistake in the facts or the law or if you have found new evidence that would change the decision. Your request must be **received within 20 days after the date of this decision**. Late requests cannot be granted.

Send your request for rehearing in writing to the Division of Hearings and Appeals, 5005 University Avenue, Suite 201, Madison, WI 53705-5400 **and** to those identified in this decision as "PARTIES IN INTEREST." Your rehearing request must explain what mistake the Administrative Law Judge made and why it is important or you must describe your new evidence and explain why you did not have it at your first hearing. If your request does not explain these things, it will be denied.

The process for requesting a rehearing may be found at Wis. Stat. § 227.49. A copy of the statutes may be found online or at your local library or courthouse.

APPEAL TO COURT

You may also appeal this decision to Circuit Court in the county where you live. Appeals must be filed with the Court **and** served either personally or by certified mail on the Secretary of the Department of Health Services, 1 West Wilson Street, Room 651, Madison, Wisconsin 53703, **and** on those identified in this decision as "PARTIES IN INTEREST" **no more than 30 days after the date of this decision** or 30 days after a denial of a timely rehearing (if you request one).
