PRELIMINARY RECITALS

Pursuant to a petition filed on July 1, 2016, under Wis. Admin. Code, §HA 3.03(1), to review a decision by Milwaukee Enrollment Services to reduce FoodShare benefits (FS), a hearing was held on August 3, 2016, by telephone.

The issue for determination is whether the agency correctly reduced petitioner's FS when she moved into a homeless shelter.

FINDINGS OF FACT

1. Petitioner (CARES # [REDACTED]) is a resident of Milwaukee County.
2. Petitioner receives FS for herself and two children. In July, 2016 she received \$281 FS based upon \$1,238.78 monthly income from SSI and caretaker supplement, and expenses that included \$400 monthly rent plus utilities.

3. Petitioner completed a renewal on June 27, 2016. She reported that she was living in a homeless shelter at no cost. There were no other changes.
4. Because petitioner's shelter deduction was reduced to zero, her FS were reduced to \$186 effective August 1, 2016. Petitioner was informed about the reduction by a notice dated June 28, 2016.

DISCUSSION

In determining the amount of FS to be issued each month, the county must budget all of the recipient's nonexempt income. 7 C.F.R. §273.9(b). From that income, certain deductions are allowed. The deductions include a standard deduction, which currently is \$155 per month. 7 C.F.R. §273.9(d)(1); FS Handbook, Appendix 4.6.2. Another deduction is the earned income deduction, which equals 20% of the household's total earned income. 7 C.F.R. §273.9(d)(2); FS Handbook, App. 4.6.3. A third possible deduction is for medical expenses exceeding \$35 in a month for elderly or disabled persons. 7 C.F.R. §273.9(d)(3); FS Handbook, App. 4.6.4. A fourth deduction is for child/dependent care. 7 C.F.R. §273.9(d)(4); FS Handbook, App. 4.6.6. The final deduction is for shelter expenses; the deduction is equal to the excess expense above 50% of net income remaining after other deductions. 7 C.F.R. §273.9(d)(6); FS Handbook, App. 4.6.7.

Before petitioner reported being in the homeless shelter she received a \$317 shelter deduction in the FS calculation, leaving net income to be \$764. Now that she does not have a shelter deduction net income is \$1,081. The higher net income means that FS are reduced. I checked the FS allotment table in the FS Handbook and it shows that a 3-person household with \$1,081 net income receives \$186 in FS.

I conclude that the reduction was correct because of petitioner's reduced shelter expense.

CONCLUSIONS OF LAW

The agency correctly reduced petitioner's FS when she moved into a homeless shelter with no monthly rent.

THEREFORE, it is

ORDERED

That the petition for review is hereby dismissed.

REQUEST FOR A REHEARING

You may request a rehearing if you think this decision is based on a serious mistake in the facts or the law or if you have found new evidence that would change the decision. Your request must be **received within 20 days after the date of this decision**. Late requests cannot be granted.

Send your request for rehearing in writing to the Division of Hearings and Appeals, 5005 University Avenue, Suite 201, Madison, WI 53705-5400 **and** to those identified in this decision as "PARTIES IN INTEREST." Your rehearing request must explain what mistake the Administrative Law Judge made and why it is important or you must describe your new evidence and explain why you did not have it at your first hearing. If your request does not explain these things, it will be denied.

The process for requesting a rehearing may be found at Wis. Stat. § 227.49. A copy of the statutes may be found online or at your local library or courthouse.

APPEAL TO COURT

You may also appeal this decision to Circuit Court in the county where you live. Appeals must be filed with the Court **and** served either personally or by certified mail on the Secretary of the Department of Health Services, 1 West Wilson Street, Room 651, **and** on those identified in this decision as “PARTIES IN INTEREST” **no more than 30 days after the date of this decision** or 30 days after a denial of a timely rehearing (if you request one).

The process for Circuit Court Appeals may be found at Wis. Stat. §§ 227.52 and 227.53. A copy of the statutes may be found online or at your local library or courthouse.
